Wow, we are thirty years old! TREDDA was founded in 1988 based on the premise that educators should take care of their retired brethren in financial distress. Back then, founding father Glenn Porter would visit Teacher Retirement System headquarters in Austin and pore over their statistical and financial data. His focus groups were single teachers and paraprofessionals who required early disability retirement. The findings indicated quality of life issues for many in these two groups who had no additional sources of income. Since our founding, TREDDA has awarded over \$800,000.00 to 125 recipients in Bexar County.

Today's retirees face many obstacles to care-free living. TRS pensions do not increase with a rise in the cost of living index. Property tax values keep surging, but not all taxes are frozen for seniors. Most seniors can expect 30 years of retirement, but they face the threat of dementia, nursing home care, and/or outliving their financial resources. Lawrence R. Powell Jr. 10/7/1927-5/2/2013 World War II Navy veteran

Lawrence Powell Jr. graduated from Jefferson High School in San Antonio. He earned a Bachelor's degree in physical education from Trinity University and a Master's degree in educational administration from Sul Ross State College. In 1953, he began a 36 year career as a public school teacher, coach, and school administrator. At Del Rio High School, Lawrence Powell taught history and coached baseball, basketball, and football from 1954 to 1966. He was especially proud of being the first coach in the Old South to play a Black quarterback in an integrated high school team (1960). In 1966 Lawrence returned to San Antonio where he was Assistant Principal and head football coach at Marshall High School for two years.

Powell dedicated his life to the development and education of the child despite having to endure physical hardship. In the early 1950's he survived a battle with polio. In 1973 brain tumor removal surgery left him deaf in one ear and facial paralysis which made hearing, speaking, and swallowing difficult. Mr. Powell served as Principal of Thunderbird Elementary from 1974-1989, which was named in his honor. Former Superintendent Jack Jordan, in recommending the name change, described Powell as a "quiet, thoughtful, unassuming individual who cares about everyone and who has touched many lives."

Powell is survived by his wife Barbara, three children, five grandchildren, and eight greatgrandchildren. Rest in peace Mr. Powell.
