President's Message

Happy New Year to everyone. TREDDA begins its thirty second year in a strong financial position. Our net assets are more than \$600,000 with no liabilities except our commitment to the twenty current awardees. Historically, TREDDA has assisted over 150 Bexar County retired teachers and support staff. The dedication and generosity of educators towards helping their peers in need has helped us persevere the lean years. Members have made donations of property, named us in their wills, and purchased life memberships. In addition, board members have successfully secured sponsors for our fundraisers. Your help will allow us to continue and expand the scope of financial assistance.

Your board met at the Girls Scouts Headquarters on December 3, 2019 for the annual meeting which is open to all members. Since our inception, the income threshold for financial aid has been the National School Lunch Program income eligibility for free lunch. The board voted to change the annual income threshold to reduced price lunch eligibility. For example, this last year the income limit for TREDDA assistance was \$16,237 annually for a household of one. For a household of one this year's income limit for reduced lunch is \$23,107. The change is effective January 1, 2020.
